Summary Narrative

Narrative

- On September 20, 2012, I received a copy of the investigative reports surrounding the alleged inappropriate conduct between IDJC staff member, [REDACTED] and current [REDACTED] inmates. The report was delivered attached to an email from Deputy Attorney General Karin Magnelli.
- The reports included two investigations into the allegations about [REDACTED]. Neither investigation revealed any inappropriate sexual contact between [REDACTED] and [REDACTED] inmates.
- The first investigation is an allegation in which [REDACTED] received inappropriate text messages from [REDACTED]. IDJC Investigator Cody Olson conducted several interviews throughout his investigation into these allegations, including interviews of [REDACTED] and [REDACTED]. During [REDACTED] interview, she denied receiving any text messages from [REDACTED]. After the investigation, Olson found little to support the allegations.
- The second investigation, is an allegation in which [REDACTED] was violating a policy regarding ongoing contact with a [REDACTED] ex-resident named [REDACTED]. This investigation was conducted by Unit Manager Terry R. Lewis. During his investigation, Lewis found the following:
 - [REDACTED] admitted to having contact with [REDACTED] prior to her release while on a home pass.
