Hi Mr. Cotton Mr. Cavazos and Ms. Jorgensen-

Mr. Cotton and I had a conversation tonight about some information that was given to me throughout the evening. I was told by Mr. Cotton to notify the three of you and not contact D.O. or write an IR so that you are able to make a decision through program.

When JR returned from home pass I had a conversation with her because KS was to return to the Unit from home pass but would not be returning. To avoid gossiping amongst the group I told JR that all I could tell her was that KS was currently in O&A and that was all the information I could give her. JR replied "It's because of me." I asked JR what she meant and she said it was because she told Mr. Cavazos everything. I questioned JR further. JR explained that on Friday she disclosed to Mr. Cavazos that KS admitted to having sex with [REDACTED] on her home passes. She stated that this has been happening since her first 24 hour home pass and [REDACTED] would come to KS's home while her mom was asleep and they would have sex and "mess around." JR said at first KS said that she had a dream that she had sex with [REDACTED] but ultimately told JR that was untrue that they really did have sex. ([REDACTED] is the name of the guy that KS said she sat in the car with at her [REDACTED] home.)

A few things came up that I was concerned about. If KS is having sex on her home pass we need to give her a pregnancy test. KS has also admitted to me that [REDACTED] I am concerned that if she is having sex that she may or may not [REDACTED] when having sex. [REDACTED] is also [REDACTED] years old according to KS she told Nurse Darla and I this in the Clinic.

JR also explained that on Christmas Day Mr. Glenn allowed KS to call [REDACTED] JR was asked to be a third and KS said "He already knows" and JR asked what she meant and she said she was calling [REDACTED] JR said she went to bed and was not a third for the phone call nor was anyone else.

Also, tonight D told me that OB has been making phone calls to [REDACTED] one as recent as a couple days ago. D said while OB was talking to her "dad" D asked OB to turn the speaker phone up because she could not hear. OB only turned it up one D again asked OB to turn it up and then D said OB gave her a weird look. OB then started talking on the phone about information that was on [REDACTED]'s facebook. (JR said KS looked on [REDACTED]'s facebook on a home pass and told OB that where it asks for Where you live: [REDACTED] had written "In your girlfriends [REDACTED]") D said she brought this information up then started arguing on the phone so she knew it was [REDACTED] D said she confronted OB after she got on the phone and told OB that she felt used and that she should not be making phone calls to [REDACTED]

I asked D if OB had ever contacted [REDACTED] before while she was in Solutions. D said yes Mr. Glenn has called [REDACTED] for her 3 or 4 times. AW KJ and JR were all aware of this as well. Angel noted that one day during PE. Mr. Glenn took OB to the unit and allowed her to call [REDACTED]
