INCIDENT SUMMARY

Victim (AP)

Today [REDACTED]-12 at approximately [REDACTED] Juvenile (AP) was attacked by peers EM, TP, KJ and JR. Prior to this TP asked me (Amy Mansell) if [REDACTED] could go up to [REDACTED] I said yes as we walked up [REDACTED] was glancing back towards [REDACTED] peers. I did not see [REDACTED] so I told TP that we could [REDACTED]. I turned to head back to the table and saw EM stand up on the table and kick (AP) in the face. The [REDACTED] at approximately [REDACTED] (AP) was sitting right across from EM. As I was running over EM jumped off the table and jumped onto (AP) and started punching [REDACTED] in the face and torso. I came up [REDACTED] I then [REDACTED].

As I [REDACTED] EM off (AP), JR jumped on (AP) and started punching [REDACTED] in the face and torso. AP laid on the ground and covered [REDACTED] head/face as much as [REDACTED] could. Peer EC stepped in and pulled JR off of (AP). As JR was pulled away TP jumped on (AP). Staff member Nicky Kimmel [REDACTED] TP and TP turned and hit Mrs. Kimmel in the face knocking her backwards. JP and KJ started punching (AP) and Mr. Peterson was able [REDACTED]. Mr. Norris stepped in [REDACTED] JR. Mr. Brian Dean [REDACTED]. Mr. Peterson [REDACTED].

KJ ran over to punch [REDACTED] again. Mr. Roberto Coronado [REDACTED]. The entire time this was going TP, EM and KJ were yelling saying "This is what you get for being a [REDACTED] snitch." And "Snitches get stitches." Mr. Ebe Amaechi [REDACTED]. [REDACTED] by Mrs. Todd. TP was [REDACTED] Mr. Dean. EM was [REDACTED] Mrs. Kimmel. As EM was [REDACTED] made gang whistles. JR was [REDACTED] Mr. Norris. After the juveniles were placed in their rooms [REDACTED]. At approximately [REDACTED] am. After returning to the Unit KJ, EM, TP and JR were yelling from their rooms to each other. (Please see addendums for what they were saying). I [REDACTED] EM later in the morning and [REDACTED] said that the plan was created by JR and TP and EM and KJ just went along with the plan because they were all tired of her snitching on them. EM stated that they had made the plan the day before while outside walking the track. They wanted to attack [REDACTED] they knew there was less staff. EM also stated that TP told them [REDACTED] EM also stated that peer KS was planning on attacking (AP) too but at the last minute EM told KS not to take part in it [REDACTED].

While responding to the [REDACTED] I, Nicky Kimmel, tried to get [REDACTED] TP [REDACTED]. During the struggle a staff member pushed me and I let go of TP [REDACTED] took that moment to turn and hit me in the face striking my left eye. I was able to recover and assist getting the attackers out [REDACTED]. I [REDACTED] EM from [REDACTED]. While doing so EM made several gang related whistles and signs at the Choices [REDACTED]

After all of the [REDACTED] were put in their room the four [REDACTED] went on talking to each other while in their rooms. The group of [REDACTED] involved showed no remorse. JR [REDACTED] bragging about EM kicking (AP) [REDACTED] in the face. TP [REDACTED] was asking the others if they still have their initiation thing. They all replied yes. They stated that KS had a signal on her hand too. TP [REDACTED] said I knew she wouldn't [REDACTED] JR [REDACTED] put paper over window. JR [REDACTED] said [REDACTED] was going to pee in [REDACTED] room, so they all started saying they were going to pee in their room. They were all talking saying that, [REDACTED] deserved it. KJ and EM were making gang whistles. JR [REDACTED] says, [REDACTED] EC held me back, that [REDACTED] is going to get it (referring to when they were in [REDACTED]). TP [REDACTED] went on for about 20 minutes saying, [REDACTED] Mrs. Kimmel that [REDACTED] touched me, I snatched her up, elbowed her and also punched that [REDACTED] face. [REDACTED] deserved it.

[REDACTED] They are still chatting and laughing. Talking to each other, talking about how it's like when they were in [REDACTED] County together. Signing you don't want to [REDACTED] with us, we will [REDACTED] you up. [REDACTED] TP signing [REDACTED] wanna dye because [REDACTED] know I caught [REDACTED] in a lie. [REDACTED] JR [REDACTED] and EM have asked a few times to write their chain because they want out of their room. JR [REDACTED] says I'm going to bed. KJ [REDACTED] replies, [REDACTED] good night, I love you; then says, wait are we all going to bed? [REDACTED] all of them singing, [REDACTED] They don't want to [REDACTED] with us we are going to [REDACTED] them up. JR [REDACTED] says I want to see (AP) [REDACTED] face. KJ [REDACTED] bragging, I hit her in the face so many times. JR [REDACTED] said I hit her a few times too. KJ [REDACTED] says, [REDACTED] it all started when EM kicked her in the face. [REDACTED] Then they all start laughing (TP, JR, KJ and EM). JR [REDACTED] says, [REDACTED] I'm more in a gang than (AP) [REDACTED] is, and I'm not even in a gang. TP [REDACTED] says, [REDACTED] You are now. JR [REDACTED] replies, true

JR [REDACTED] replies, true, I'm down man, I can't wait to get out. KJ [REDACTED] asked JR [REDACTED] has a blue bandana. [REDACTED] Talking about brass knuckles with barbwire. JR [REDACTED] says, [REDACTED] I am going to be mobbing in blue. JR [REDACTED] says, [REDACTED] 208 mother [REDACTED] [REDACTED] yea, TP [REDACTED] said loudly. They are talking about partying together when they get out. And talking about past drinking times and who likes what kind of alcohol. They all agree that they are alcoholics and druggies. [REDACTED] KJ [REDACTED] says, cricket, cricket and they TP [REDACTED] and KJ start whistling and JR [REDACTED] does not know how and is asking how to whistle. [REDACTED] JR [REDACTED] says [REDACTED] does not give a [REDACTED] and is going to do whatever [REDACTED] wants and is going to do what [REDACTED] wants. When [REDACTED] gets out since she is already on sanctions [REDACTED] is going to segregate [REDACTED] and beat up whoever [REDACTED] wants. [REDACTED] they are banging on their doors and laughing. [REDACTED] JR [REDACTED] informed [REDACTED] group that [REDACTED] took her shirt off, TP [REDACTED] and KJ [REDACTED] started

saying, big ol' [REDACTED] TP [REDACTED] told her to show me your [REDACTED] JR [REDACTED] did. [REDACTED] I want to break so many rules and be reckless. KJ [REDACTED] is encouraging JR [REDACTED] to strip. [REDACTED] was getting ready to move JR [REDACTED] said, [REDACTED] wait I need to get my clothes back on [REDACTED] and TP [REDACTED] said, [REDACTED] op, I better put my clothes back on too! [REDACTED] The [REDACTED] were separated into different rooms.

Please be advised that this group of girls went into their room about 7:00 AM and started talking to each other then and did not stop until they were separated at 9:30 AM.

Mrs. Todd and I (Mansell) completed room searches today while this [REDACTED] were in class. JR KJ and TP [REDACTED] all had a piece of paper that had the same thing written on each. It had the number 208 (presumed gang name) and their names with nicknames by each of them. It had a list of weapons and a list of cars. On the top part of the paper it said "Kill Zombie [REDACTED] JR [REDACTED] also had inappropriate notes in [REDACTED] room between [REDACTED] and peer TP [REDACTED]. KJ and JR [REDACTED] had calendars taped on their doors and on the 26th the day of the attack KJ [REDACTED] wrote beat the [REDACTED] out of AP JR [REDACTED] had a note on the 26th that said jumped (AP) KJ and JR [REDACTED] did not have access to their calendars with pens or pencils until after they agreed with the egregious behavior protocol. Therefore they broke the egregious behavior protocol by glorifying their actions. All the information was passed onto Safety and Security Supervisor Julie McCormick.
